Corporate Membership Categories

I. Governing Membership. Open to any person, firm, entity, organization, company, or corporation engaged in or with an interest in the moving industry.

Benefits of Membership:

- Two listings—alphabetical and geographical—in IAM print and online Membership Directories (Online listing will include a 35-word description of services, and industry licenses, affiliations, certificates)
- Three points of contact listed in each directory
- Three print copies of the IAM Membership Directory
- Early Bird Annual Meeting registration rate for all attendees regardless of registration date
- Discount (10 percent) on regular Exhibitor Fees at Annual Meeting
- Three subscriptions to *The Portal* magazine (six issues per year)
- Reduced initiation fee (25 percent discount) for Receivable Protection Program (RPP)
- Voting rights on all matters impacting Governing Members, including final approval of amendments/revisions to IAM by-laws affecting any category of IAM membership

Fees for Governing Membership: \$3,000 annually, billed in two installments (June and December). Those applying for new membership submit \$2,000 with application, covering a one-time initiation fee of \$500 and \$1,500 for the first six months of membership. Initiation fee waived for current IAM members upgrading to Governing membership.

II. Core Membership. Open to any person, firm, entity, organization, company, or corporation engaged in or with an interest in the moving industry, unless said entity is a Transportation Service Provider (TSP) offering door-to-door through bill of lading service capabilities to the U.S. Government, in which case Governing membership is required.

III. Supplier Membership. Open to any person, firm, entity, organization, company, or corporation providing goods or services to the moving industry, but not actively engaged in the moving process.

Fees for Supplier Membership: \$650 billed annually. Those applying for new membership submit \$1,150 with application, covering a one-time initiation fee of \$500 and dues of \$650 for one year from effective date of membership.

GOVERNING MEMBERSHIP

Governing Membership shall be open to any person, firm, entity, organization, company, or corporation engaged in or with an interest in the moving industry.

Membership application must include two sponsorship letters from two different Governing or Core Members in good standing.

FEES FOR GOVERNING MEMBERSHIP: Submit US \$2000 covering initiation fee (\$500) and dues (\$1500) for the first six months of membership. Dues of \$1500 billed twice yearly, June & December.

CORE MEMBERSHIP

Core Membership shall be open to any person, firm, entity, organization, company or corporation engaged in or with an interest in the moving industry, unless that entity is a Transportation Service Provider (TSP) offering door-to-door through bill of lading service capabilities to the U.S. Government, in which case Governing Membership is required.

Membership application must include two sponsorship letters from two different Governing or Core Members in good standing.

FEES FOR CORE MEMBERSHIP: Submit US \$1150 covering initiation fee (\$500) and dues (\$650) for one year from effective date. Dues of \$650 billed annually in December.

SUPPLIER MEMBERSHIP

Supplier Membership shall be open to any person, firm, entity, organization, company, or corporation providing goods or services to the moving industry, but not actively engaged in the moving process.

Membership application must include two sponsorship letters from two different Governing or Core Members in good standing.

FEES FOR SUPPLIER MEMBERSHIP: Submit US \$1150 covering initiation fee (\$500) and dues (\$650) for one year from effective date. Dues of \$650 billed annually in December.

- 01. FULL SERVICE AGENT (FSA):** An agent who performs a full range of origin/destination services for commercial and U.S. Government (military) shipments.
- 02. MILITARY FULL SERVICE AGENT (MSA):** An agent who performs a full range of origin/destination services for U.S. Government (military) shipments ONLY.
- 03. COMMERCIAL FORWARDER (CRF):** A company that handles domestic and/or international shipments via container from origin to destination, but is not a DOD-approved forwarder and/or Transportation Service Provider (TSP).
- 04. MILITARY TRANSPORTATION SERVICE PROVIDER (TSP):** A company that handles only military and DOD domestic and/or international shipments door-to-door from origin to destination.
- 05. CUSTOMS HOUSE BROKER (CHB):** Processes customs documentation.
- 06. RELOCATION COMPANY (REL):** A company that provides a full range of services beyond those usually associated with the HHG moving process (i.e., home buying/selling, job placement assistance, temporary housing, etc).
- 07. GENERAL AGENT (GGA):** A company that represents one or more carriers in such matters as identifying agents and paying agents for services rendered. Supports DOD ITGBL program.
- 08. TRUCKING COMPANY/MOTOR FREIGHT CARRIER (TMC):** A company that transports property by motor vehicle, including truck, trailer, semitrailer, or tractor.
- 09. AIR FREIGHT FORWARDER (AFF):** A commercial forwarder that specializes in the movement of cargo via air carriers.
- 10. OCEAN CARRIER (OOC):** A steamship company that provides over-water transportation via ocean vessels.
- 11. NON-VESSEL OPERATING COMMON CARRIER (NVO):** A firm that has an FMC surety bond and a tariff on file to move commercial personal property and other cargo.
- 12. LOGISTICS MANAGEMENT (LOG):** A company that specializes in supply chain management (i.e., providing of services and related information between the point of origin and the point of destination).
- 13. RECORD STORAGE (REC):** A company that provides record, media, and archival storage and management services.
- 14. OFFICE MOVER (OMO):** A firm involved in the handling of office relocation for commercial customers.
- 15. DIRECT PROCUREMENT METHOD CONTRACTOR (DPM):** A contractor who provides origin and destination services for the DOD and Department of State DPM programs.
- 16. NON-TEMPORARY STORAGE CONTRACTOR (NTS):** A firm that is a long-term storage contractor for DOD and other entities.
- 17. INSURANCE AND TRANSIT CLAIM SERVICES (ITC) :** Includes **(a) full service insurance firms** that provide all types of insurance to companies in the moving and storage industry, including shipment, cargo, vehicle, and building insurance; may also arrange for performance and surety bonds, damage inspections, or repair of damaged articles, and provide for claim settlement for client carriers. **(b) claim settlement service firms** that specialize in providing inspection, estimating cost for repair of damaged shipments, and assisting in processing a shipper’s claim for loss or damage; provides clients reports on claims.
- 18. DAMAGE INSPECTION-FURNITURE/APPLIANCE REPAIR SERVICE (DIR):** A firm whose primary business is to inspect, provide estimates for repair, and perform or arrange for repair of damaged articles upon request of the shipper, carrier, or claims settlement agent.
- 19. PORT AGENT (PTA):** A firm that provides surface and/or aerial port services to include consolidating shipments, stuffing/unstuffing ocean containers, customs clearance, building/tearing down air pallets, picking up and delivering ocean containers/pallets to the surface/aerial ports. May arrange surface linehaul services for military and/or commercial cargo.
- 20. AUTOMOBILE RELOCATION (ARL):** An organization that specializes in the relocation of automobiles and other vehicles.
- 21. ANIMALTRANSPORTATION (ANM):** A firm involved in the relocation and transportation of pets and other animals.
- 22. TECHNOLOGY SERVICES (TEK):** A firm that specializes in developing/selling computing, communications and tracking devices, software, services, and support to companies in the moving industry.
- 23. TRANSPORTATION BILLING AND AUDIT SERVICES (TBA):** A company that performs pre-move and/or post-move audits on commercial and military invoices.

- ☐ **24. PACKAGING/ CONTAINERS/ MOVING EQUIPMENT (PCM):** Includes firms that specializes in (a) the design, manufacturing, and/or sale of cartons/packing material to companies involved in providing origin packing services (*does not include* local moving agents selling cartons/packing material to shippers); the design, manufacturing, and selling of shipping and/or storage containers used by the moving industry, including liftvans and/or storage pallets; the provision of other moving equipment such as blankets, straps, dollies, ramps, labeling, etc.
- ☐ **25. PORT AUTHORITY (PPP):** Entity that operates an ocean/aerial port.
- ☐ **26. PERSONNEL RECRUITMENT AND TRAINING (PRT):** Finds personnel—consultants, temporary, part-time or fulltime workers— to fill specific vacancies in a company and/or provides training specific to the moving industry or on general business practices.
- ☐ **27. PUBLIC WAREHOUSE-DISTRIBUTION (WWD):** A company that warehouses and distributes stored commodities to customers.
- ☐ **28. OCEAN CARRIER CONFERENCE (OCC):** An organization of ocean carriers that publishes ocean tariffs or manages service contracts.
- ☐ **29. FLATBED OPERATIONS (FBO):** A firm that provides trucking services for containerized household goods shipments.
- ☐ **30. EXHIBIT SERVICES (EXS):** A firm that handles domestic and/or international exhibit and tradeshows.
- ☐ **31. TARIFF AND RATE FILING SERVICES (TRF):** A company that processes and files rates on behalf of Transportation Service Providers (carriers).
- ☐ **32. SPECIALTY SERVICES (SPS):** A firm that sells and/or provides specialized origin/destination services for items that require unique handling; includes international appliances sales and service, assembly/disassembly, crating/uncrating, handyman, hoisting, staging services, etc.
- ☐ **33. FINE ARTS TRANSPORTATION (ART):** A firm that specializes in the moving of fine art objects such as museum articles, paintings, antiques, and similar extraordinarily high-value articles.
- ☐ **34. TRANSPORTATION ATTORNEY (LAW):** Attorney specializing in transportation law.
- ☐ **35. PRINTING SERVICE (PTS):** A company that provides printing services for the household goods industry (i.e., bills of lading, inventories, etc.).
- ☐ **36. COURIER/EXPRESS DELIVERY SERVICES (CED):** A company employed or contracted to deliver parcels and packages and providing features such as speed, security, tracking, signature, specialization and individualization of services, and committed delivery times.
- ☐ **37. INDUSTRY PARTNER (INP):** An entity that arranges for and pays a carrier to move personal property belonging to its employees. Such entity may be a government agency, multi-national organization, corporation, individual business, etc.
- ☐ **38. TRADE ASSOCIATION (TAS):** An organization that represents the interests of companies involved in some aspect of the moving and relocation process.
- ☐ **39. CONSULTING SERVICES (CNS):** A company that provides transportation and/or general business consulting to companies involved in the moving and relocations process.
- ☐ **40. APPLIANCES & ELECTRONICS (AEL):** A company that sells electronic products that are suitable for international use, including major appliances, small appliances, televisions, stereo systems, digital cameras, video cameras, and more .
